Notification

It is notified for information of all concerned that on the request of students, the Vice-Chancellor, in pursuance of the approval of the Academic Council, has accorded permission to grant a special Chance to the students of B.Ed (for the session 2017-2019, 2018-2020 & 2019-2021) who couldn't pass the course within the admissible chances as per ordinance, subject to fulfillment of following criterion/conditions.

- 1) The Students who enrolled himself/herself for their particular course in the year 2017 onwards and availed all his/her admissible chances as provided in the scheme of Exam, stands availed/exhausted till the last exam i.e. May 2023 shall only be eligible for this special chance. If anyone who has any admissible chance to pass the degree at his/her credit, as of now, shall not be eligible for this special chance.
- 2) The examination form panel for this special chance shall be live from 25.04.2024 to 20.05.2024 on the university portal.
- 3) For this special Chance, Exam wise/course wise fee shall be chargeable as under:

- 4) The Students are also advised that before submission of online examination form and fee, they must check/ensure their eligibility and in case of any doubt, they must confirm it from the concerned Result Branch. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination, form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students desirous of availing this chance are advised to read the following.
 - i) The Examination for the special chance shall be conducted as per the scheme/syllabi, as applicable for each course.
 - ii) The Examination forms and fee shall be filled up 2017 onwards through online mode as notified by the University.
 - iii) The Schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of result.
 - iv) This Special chance is admissible to complete the Degree(Course) for such students who have re-appear in one or more papers (subjects).
